Summary of Key Indicators

- 1. Average Daily Membership (ADM) Overview
 - o Original Budget: 155 ADM
 - o YTD Actual: 154.67 ADM
- 2. The school's original budget shows a net income for FY25 of \$89,585. This result would bring the district's fund balance to \$1,059,494, or 37% of total expenditures.
- 3. Projected Days Cash on Hand for the fiscal year-end is 122 days.
- 4. Projected Debt Service Coverage Ratio at fiscal year-end is 1.29.

Financial Report Key Points

- 1. As of month-end, 58% of the year was complete.
- 2. Cash Balance as of the reporting period is \$812,164 which is down from the previous month.
- 3. Revenues received at end of the reporting period 57.8%
- 4. Expenditures disbursed at end of the reporting period 54.4%
